

They Know, They Agree, They are Accountable

On July 3, 2022, the Montana Clean Resources Committee of the Montana Assembly mailed a 'Notice and Agreement of the Facts in Evidence' to living souls acting as public officials.

The Notice contained factual evidence of:

- Geoengineering, commonly called 'chemtrails'.
- That 'chemtrails' violate treaties.
- That their duty and obligation is to end the 'chemtrails'.

The Notice also contains the following statement:

“by our sending you this good faith agreement, we do attempt to ascertain all the facts in honor. If you have any reason or proof to suggest or provide to us, that the foregoing statements of the facts are not true, you are being offered the opportunity to refute these offered facts so as to clear yourself of any assumptive contractual awareness of the truth of such facts.”

As of August 27, 2020, no refutation of the facts in evidence has been offered by the recipients of the Notice.

Therefore, they know, agree, and fail to do their duty and obligation.

The Montana Clean Resources Committee publishes this document to hold them accountable.

Every living soul acting as public official on the list (pp 2-8) received a Notice.

Each Notice contained the correct FirstName, SurName, and OfficialTitle, as well as the appropriate oath of office in statement #3.

The oath for a Montana State official appears in statement #3 in the Notice (page 10).

Notice and Agreement of the Facts in Evidence

Dear FirstName,

We are asking you in honor according to recognized law binding on all service providers in the United States to agree that the following is binding and obligatory upon your office.

It is agreed upon with no dispute to the fact forthcoming from you FirstName SurName, living soul, acting as OfficialTitle:

1. that the LORD God made man a living soul. **Gen 2:7** And the LORD God formed man *of* the dust of the ground, and breathed into his nostrils the breath of life; and man became a living soul.
2. that for a living soul to act as an officer of government, an oath of office must be sworn.
3. that you have a true valid oath as written in the Constitution of the State of Montana, ARTICLE III, Part III, Section 3. Oath of Office. "I do solemnly swear (or affirm) that I will support, protect and defend the constitution of the United States, and the constitution of the state of Montana, and that I will discharge the duties of my office with fidelity (so help me God)."
4. that the oath is a lawful requirement for all living souls who wish to act as officers of government and all who refuse to acknowledge and submit to that fact are imposters who lied to get their job.

5. that the only reason government exists is to protect living souls. “We, the People of the United States, in order to form a more perfect union, establish justice, ensure domestic tranquility, provide for the common defence, promote the general welfare, and secure the blessings of liberty to ourselves and our posterity, do ordain and establish this Constitution for the United States of America.”
6. that the “Convention on the Prohibition of Military or Any Other Hostile Use of Environmental Modification Techniques (ENMOD)” treaty was signed by the United States and ratified December 13, 1979. <https://2009-2017.state.gov/t/isn/4783.htm>
7. that the Convention on the Prohibition of Military or Any Other Hostile Use of Environmental Modification Techniques (ENMOD) became the "supreme law of the land" under the Supremacy Clause of the U.S. Constitution, which gives ratified treaties the status of federal law.
8. that Article I of this treaty defines the term "environmental modification techniques" as any technique for changing -- through the deliberate manipulation of natural processes -- the dynamics, composition or structure of the Earth, including its biota, lithosphere, hydrosphere and atmosphere, or of outer space.
9. that "environmental modification techniques" have been observed, measured, and documented extensively. These techniques are commonly called “chemtrails.” <https://www.geoengineeringwatch.org/>
10. that the chief of staff of the United States Air Force issued a directive to examine the concepts, capabilities, and technologies the United States will require to remain the dominant air and space force in the future. The result of this directive was the document "Weather as a Force Multiplier: Owning the Weather in 2025" published in August 1996. <https://ia802603.us.archive.org/1/items/WeatherAsAForceMultiplier/WeatherAsAForceMultiplier.pdf>
11. that the purpose of "Weather as a Force Multiplier: Owning the Weather in 2025" is to outline a strategy for the use of a future weather-modification system to achieve military objectives by using proven weather-modification intervention technologies.
12. that the term “weather-modification” means the introduction by man, directly or indirectly, of substances or energy into the air.

13. that the weather-modification system is the set of intervention techniques used to modify the weather, they involve infusing either energy or chemicals into the meteorological process in the right way, at the right place and time, and control and modification of the ionosphere and near-space environment. The intervention could be designed to modify the weather in a number of ways, such as influencing clouds and precipitation, storm intensity, climate, space, or fog. In extreme cases, it might involve the creation of completely new weather patterns, attenuation or control of severe storms, or even alteration of global climate on a far-reaching and/or long-lasting scale.
14. that in the United States, weather-modification will likely become a part of national security policy with both domestic and international applications and government will pursue such a policy.
15. that the United States signed and ratified the 1979 Convention on Long-Range Transboundary Air Pollution and is party to this treaty.

16. that the 1979 Convention on Long-Range Transboundary Air Pollution became the "supreme law of the land" under the Supremacy Clause of the U.S. Constitution, which gives ratified treaties the status of federal law.
17. that according to treaty, "Air Pollution" means the "introduction by man", directly or indirectly, of substances or energy into the air resulting in deleterious effects of such a nature as to endanger human health, harm living resources and ecosystems and material property and impair or interfere with amenities and other legitimate uses of the environment."
18. that there is active "introduction by man", directly or indirectly, of substances or energy into the air. <https://youtu.be/4x3z35HA6JQ>
19. that this active "introduction by man", known commonly as "chemtrails", has been observed, documented, quantified, and verified.

20. that the living souls acting as The Montana Assembly Clean Resources Committee object to the pollution of the air and environment by chemtrails and the use of weather-modification. We direct our public servants in their official capacity to stop the chemtrails and weather-modification.
21. that now that you have been given notice and knowledge of these facts, you have a duty and obligation as a living soul to make known the same to some judge or other person in civil or military authority under the United States, and as **OfficialTitle**, you have a duty and obligation to stop the “chemtrails” and “weather-modification.”
22. that failure to perform duty and obligation convinces you of “Misprision of Felony” 18 U.S. Code § 4 - Whoever, having knowledge of the actual commission of a felony cognizable by a court of the United States, conceals and does not as soon as possible make known the same to some judge or other person in civil or military authority under the United States, shall be fined under this title or imprisoned not more than three years, or both.
23. that per 50 U.S. Code § 1520 Informed Consent has never been given. Any implied, perceived or represented consent is hereby officially and permanently revoked.


