
Please reference Article IV to understand your obligation to protect our persons and property without arrest, invasion of our privacy, or other imposition.

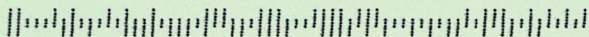
