



The Montana Assembly Protocols (Rules of Order)

The Montana Assembly focuses on educating people about their political correction process using Anna von Reitz's method, helping them correct their political status records, and preparing them to address economic issues such as: reclaiming property rights, mortgage relief, personal tax relief, gaining the financial means we require to sustain ourselves, and stopping taxation or assumed ownership by foreign corporations. No other assembly is recognized by The Montana Assembly as being lawful or valid.

Our Assembly conducts its affairs in a mature and business-like way. There is no "cloak and dagger" atmosphere at all. Any questions are addressed in a forthright manner and resolved. We conduct business, in honor, where clear simple goals are maintained.

The creations brought forth through Committee and Assembly meetings remain the property of The Montana Assembly. By property we mean any drawings, conference calls, symbols, flag, seals, The Montana Assembly Declaration, Notarial Witness/Recording stamps, and/or records submitted to, and accepted by, The Montana Assembly. Those in possession with The Montana Assembly property, found outside The Montana Assembly, that are not donated examples are subject to fines starting at (\$100,000.00) One hundred thousand and up to One hundred million (\$100,000,000.00) of The United States of America currency without the written explicit permission of The Montana Assembly which is reviewed by the Oversight Committee and enforced by the Seargent at Arms.

To be a lawfully participate in The Montana Assembly one must have corrected one's political status using the #928 Basic Package of editable forms, and/or The One Pager, with 2 witness testimonies and a photo copy of the birth certificate, and have recorded this paperwork with a Recording Secretary - International Notarial Witness which will publish all documents into our Land Recording Records.

Those who are ineligible to vote as an Montana State Citizen or as an Montana American National status are those with apparent health disabilities that are not capable of handling such a position, in other words, not able to make cognitive decisions because of the disability. Anyone in the Assembly can bring the situation to anyone in The Oversight Committee for a review to decide if it is apparent.

When participating in The Montana Assembly, verification of the land recorded documents, listed above, is required or the one pager with the 2 witness testimonies and a photo copy of the birth certificate. You will be required to provide your land recorded number, date, County, and State. If you're not currently standing on the land you cannot be a participant/member. (Land jurisdiction does not allow for dual jurisdiction.)

Guests are those who have not yet Land Recorded their documents, and those who have been invited to a meeting as a guest. Guests are not allowed to participate, unless asked by the assembly, during the business meeting. However, after the business meeting they may participate in the discussion session.

All participants have equal rights and the same obligations.

Full and free discussion of every motion is open to all Montana State Nationals or Montana State Citizens.

No person can speak until recognized by the moderator.

Only one question or motion at a time may be considered, and only one person may have the floor at any one time. When requesting to speak, state "may I and your name", then state your name and county when called upon by the moderator. Once you are recognized, the floor is yours for (3) three minutes. Participants have a right to know what the immediate pending question or motion is and after discussion to have it restated before the question or motion goes forward.

Personal negative remarks and/or disruptive behavior are always out of order, regardless of whether it takes place during a meeting, through emails, or phone calls. Perpetrators may be banned from any meetings, conference calls and/or participation in assembly business.

Disruptive behavior includes the following:

1. Malicious gossip
2. People raising "concerns" of a juvenile or petty nature
3. Using such "concerns" to spread doubt and mistrust of any participant, or functions within the group
4. Deliberate miscommunication between working groups and participants
5. Unnecessary talk about fear and danger
6. Petty or unsubstantiated accusations of wrong-doing
7. Passive aggressive behavior
8. Sending unwarranted and personal attacks through e-mails or any other media

Please note all participants shall work with their County Chairman with any disputes and or infractions, or concerns, and or questions before going to the state coordinator, or Anna. Anna is not a part of The Montana Assembly and cannot make any decisions regarding The Montana Assembly.

The infractions will be reviewed and discerned by the Rules Oversight Committee.

The moderator for The Montana Assembly has the authority to mute any disruptor and/or remove them from the call.

The Rules Oversight Committee is formed from the County Coordinators, now called County Chairmans, or their designated Proxy. They review any infractions of the above eight (8) rules for actions to be taken, if any, on the consequences and recommendations of their determination. They

will report their findings at the next Assembly meeting. A participant can appeal in writing (e.g., email). The Rules Oversight Committee will review the appeal, deliberate, and present a final determination. It takes 2/3rds of the County Chairmen of the Rules Oversight Committee to affirm any determination. All interruptors and Provocateurs will be added to the current listing with a simple description. A County Chairman being reviewed by the Rules Committee cannot participate in their determination.

A two-thirds vote of the County Chairmen is required for any determination to pass. A County Chairman who is unable to attend a meeting where a vote is to be taken or required may use one of the following methods to vote: by E-mail, phone call, text or a designated proxy. The vote must be sent to the State Coordinator prior to the meeting. A return confirmation by the State Coordinator must be received by the County Chairmen.

Note penalties, determined by the Rules Oversight Committee are listed below for details

Interruptors: Removed from business meetings and any committee meetings for a minimum of (3) three months to (6) six months. Upon returning they serve a probationary period of (3) three months with no voting and no committee meetings.

Provocateurs: Removed from business meetings and any committee meetings for minimum of (1) one year, and up to a permanent banning. Upon returning, if not banned, they serve a probationary period of (3) three months with no voting and no committee meetings.

Those that have chosen to quit The Montana Assembly, through verbal or written notice, and then return, must go through the 928 committee to be re-vetted to join the assembly again. Once through the 928 committee they also have a (3) three month probation period before they can be a State National or State Citizen and gain elector rights as well as be able to work on any committee for those (3) three months.

Those that have chosen to take a sabbatical, for more than (6) months, for reasons other than health, need to include in writing a brief explanation for the sabbatical and send that to both their County chairman and State coordinator. They will need to resubmit their docs to the 928 committee for re-vetting upon returning.

The Oversight Committee is over all committees which is formed by participants in good standing and has continually contributed to The Montana Assembly for a minimum of (2) two years. Participation is limited to those with the experience of active participation in committee work and holding offices/positions, and other assembly work/functions. Decisions made by the Oversight Committee are final. All participants come to join the Oversight Committee by invitation only. The open time frame is during the month of May each year.

Silence gives consent. Those who abstain allow the decision to be made by those who do vote. Choices are Yay, Nay or Abstain.

The moderator should always remain impartial.
