Incorporated businesses have a Public Duty to obey the Public Law and can be fined \$50,000.00 per day per location or be faced with loss of charter for violation.

In the event that this matter has been overlooked, The Montana Assembly is providing an additional 10 days to resolve this matter. A copy of the notice is attached,<sup>ii</sup>

Dear W. Craig Jelinek,

The Montana Assembly has noticed that Costco Wholesale Corporation requires People to wear face coverings and/or being vaccinated as a condition of entry. The Montana Assembly (We the People) has standing to demand the cessation of these unlawful acts. To require a mask to enter a place of public accommodation is an unlawful act. Costco Wholesale Corporation is hereby noticed to CEASE AND DESIST to require face coverings or being vaccinated for entry.

- We, the People created the Constitution, the employment contract for elected government employees.
- The Montana Secretary of State (an elected employee) is bound by oath to the Constitution(s).
- The Montana Secretary of State is responsible for authorizing and maintaining Articles of Incorporation for corporations franchised in Montana.
- As a condition of its charter (Articles of Incorporation), Costco Wholesale Corporation has stated that it is a public benefit corporation.
- Therefore, Costco Wholesale Corporation is a place of public accommodation and must be of benefit to the People.
- Costco Wholesale Corporation, in their code of ethics, have pledged to obey the law.

- Requiring someone to wear a face covering or be vaccinated as a condition to assemble in your place of public accommodation is an infringement of the right
- protected under the U.S. Constitution, the highest law of the land. No law is valid or lawful that violates the Constitution. No health order, emergency order, state of emergency, municipal ordinance, or store policy may suspend or violate the Constitution, period.
- Therefore, by requiring People to wear a face covering or be vaccinated before entering a place of public accommodation, Costco Wholesale Corporation violates both its' own code of ethics, and the highest law of the land.

The corporate policy of Costco Wholesale Corporation does not apply to People.

Requiring People to wear masks violates its Corporate Charter, Code of Ethics, and the Public Law.

The Montana Assembly hereby provides NOTICE to Costco Wholesale Corporation to CEASE AND DESIST to require People to wear masks.
