

Meeting Minutes Montana Assembly - July 16, 2026

Bevins reading times three as per protocol: no response to all three readings.

Roll Call: counties present are Sanders, Carbon, Ravalli, and Flathead

Last recorded meeting was on May 21st, 2026 with Flathead, Sanders, and Ravalli. Informal meeting held on June 18th, 2026 with Sanders and Ravalli counties present.

Minutes of May meeting reviewed. Motion to accept minutes offered and seconded.

Old Business: Jeffry and Wayne have been researching specific aspects of the Assembly. Discussed relationship of Assemblies with the Federation. Who is the Federation? Jeffry has been analyzing Anna's articles via AI. He has had little luck being able to verify information regarding who is the Federation. The 6,000 articles supposedly written by Anna, according to AI, shows that Anna is the single source of information. Therefore, it is determined that Anna is the Federation.

Having difficulty vetting people. Wayne has petitioned Terry Saum who runs the WA Assembly and is assistant to Anna. Was able to get access to coordinator's meeting. Petitioned for access to LRO.
